ASSOCIATE MEMBERSHIP (NON-VOTING MEMBERSHIP)

Qualifications: A person who is eligible for Associate Membership shall be an individual who is otherwise eligible for Voting Membership (meets one or both of the following: 1.) has valid proof of completion of a full course of study prescribed for training of the Paralegal; or 2.) has been employed as a Paralegal for a minimum of twelve (12) months), **but:**

- (1) is not currently employed as a Paralegal;
- or**
- (2) has not provided proof of completion of the requisite 6 CLE hours for renewal of Voting Membership.

Note: *An Associate Member who becomes eligible for Voting Membership is required to upgrade his/her membership to that of a Voting Member.*

Associate Members in good standing may fully participate in the social and educational affairs of AAPA, but shall not have the right to vote, hold office or directorship as a voting Board member, or participate in the business affairs of AAPA unless such right or rights is/are granted to a Non-Voting Member by the Board.

Associate Members are prohibited from using membership in AAPA for the purposes of marketing or supplying products or services to the legal profession, except those services offered by a Non-Voting Member as an intern or freelance Paralegal.
